BE IT FINALLY RESOLVED, that the Sault Tribe agrees to receive the additional Indian Health Service funding and will ensure that the funding is utilized in an efficient way to complete identified projects within the proposed funding allotment to the benefit of the Sault Tribe and the Health Division facility.

Marie Tribe of Chippewa Indians ("Tribe") hereby authorizes the Tribal Chairperson or his designee, to negotiate a lease(s) of Tribal Trust lands as they deem to be in the best interest of the Tribe, to the Tribal EDC, upon such terms and conditions as they may set out, and to execute such further documents, and certificates as may be necessary, to complete the negotiations of the lease transaction.

BE IT FINALLY RESOLVED, that the Board of Directors of the Sault Ste. Marie Tribe of Chippewa Indians ("Tribe") hereby authorizes the Tribal Chairperson or his designee, to negotiate a lease(s) of Tribal Trust lands (or EDC Lands), as they deem to be in the best interest of the Tribe, to the Lume Cannabis Company, upon such terms and conditions as they may set out, and to execute such further documents, and certificates as may be necessary, to complete the negotiations of the lease transaction.
