BE IT FURTHER RESOLVED, that the Board of Directors of the Sault Ste. Marie Tribe of Chippewa Indians hereby authorizes the Tribal Chairman, or his designee, to negotiate a contract between the Sault Ste. Marie Tribe of Chippewa Indians and Aaron Peterson Studios, with review of the Legal Department, to carry out the intent of this resolution.

Moved by Director Freiheit, supported by Director Hampton, to approve a Resolution, Waiver of Sovereign Immunity and Consent to Waiver of Tribal Court Jurisdiction Service Contract for Magellan Advisors, LLC.

Moved by Director McKechnie, supported by Director McRorie, to Table.

Motion to Table carries with Directors' Causley-Smith, Lee, Freiheit, Morrow, Sorenson, McKechnie, McRorie, Hampton approving; Directors' McKerchie, LaPlaunt, Borowicz opposing.

Moved by Director Sorenson, supported by Director Causley-Smith, to overrule Chairman's decision to remove the person from the closed session meeting.

Roll Call Vote: Motion fails with Directors' Sorenson, McKerchie, Causley-Smith, Borowicz, Morrow supporting; Directors' McRorie, LaPlaunt, Freiheit, Lee, Hampton opposing; Director McKechnie abstaining; Tie vote - Chairman Lowes opposing.

Moved by Director Freiheit, supported by Director McRorie, to approve Resolution 2023-244, Amending Chapter 14: Rules of Parliamentary Procedure Ordinance Section 119: Disciplinary Procedures.

NOW THEREFORE BE IT RESOLVED that Chapter 14 Section 119: Disciplinary Procedure, shall be amended to read as follows:

14.119 Disciplinary Procedures.

- All persons present at a meeting shall obey the legitimate orders of the Chairperson. The Chairperson has the duty to rule on all questions of parliamentary procedure affecting the proceedings of the Board.
- (2) The Chairperson has the authority to rule any Board member as being out of order if he or she violates the rules of parliamentary procedures set forth in this Chapter or Robert's Rules of Order Newly Revised, as applicable.
- (3) For serious or repeated violations of order, any Board member can move to penalize the offending member or the Chairperson can inquire as to whether the Board desires to penalize the offending member. A motion to penalize can include that the offending member be censured or be required to leave the meeting, or both. As used herein, "censure" refers to the authority of the Board to impose a fine or reduce or suspend any benefit(s) that Board members receive (except the right to attend subsequent meetings); provided, however, that any such fine or reduction or suspension of any benefit(s) shall not exceed five thousand dollars (\$5,000.00) per censure. The motion requires a second and must be approved by a Simple Majority. The provisions of Section 14.110 may be utilized to prevent the offending Board member from voting on a motion to penalize.

All other sections and subsections of Chapter 14 shall remain unchanged

Moved by Director Causley-Smith, supported by Director McRorie, to approve Resolution 2023-245, Resolution to Support the Legislation to Create the Truth and Healing Commission on Federal Indian Boarding School Policies Act in the United States.

NOW, THEREFORE, BE IT RESOLVED, that the Board of Directors of the Sault Ste. Marie Tribe of Chippewa Indians does hereby support the "Truth and Healing Commission on Indian Boarding Schools Policies in the United States Act"; and

BE IT FURTHER RESOLVED, the Board of Directors of the Sault Ste. Marie Tribe of Chippewa Indians urges the House and Senate to pass the "Truth and Healing Commission on Indian Boarding Schools Policies in the United States Act"; and

BE IT FINALLY RESOLVED, the Board of Directors of the Sault Ste. Marie Tribe of Chippewa Indians calls on President Joe Biden and Interior Secretary Debra Haaland to garner the full authority of the Biden Administration to support these bills.

Motion carries with Unanimous Consent.

Moved by Director Causley-Smith, supported by Director Freiheit, to approve Resolution 2023-246, Naming Transformational Shelter.

NOW, THEREFORE, BE IT RESOLVED, that the Sault Ste. Marie Tribe of Chippewa Indians hereby designates the Transformational Shelter be known as "Bgwasendam Gamigong" Lodge of Hope.

Motion carries with Unanimous Consent.

Moved by Director Sorenson, supported by Director Morrow, to appoint Kimberle K. Gravelle to the Special Needs/Enrollment Committee, for a 2-year term (technical correction, indicated 4-year term in request) expiring July 2025.

Motion carries with Director Freiheit opposing.

Moved by Director Sorenson, supported by Director Causley-Smith, to send two removal petitions on Kim Hampton to an external hearing board to decide the outcome; Tribal Court can facilitate the process using the Legal Department's Special Projects budget.

Moved by Director LaPlaunt, supported by Director Freiheit, to Table.

Motion to table carries, with Directors' LaPlaunt, McKechnie, Lee, Hampton, McRorie, Freiheit approving; Directors' Sorenson, Morrow, Borowicz, McKerchie, Causley-Smith opposing.
